#### **TREASURER'S REPORT - NANCY MCMANUS**

Dues for 2020 are currently being collected as of the September 11 breakfast. Please check your 2019 Blackhawk unit directory for your name, address and telephone number as listed. If there have been changes in this information or in your email address, please notify Nancy McManus (309-794-0490) or Mike Daly (309-721-6005).

Also included is the coding for each individual membership – the key for the letters is found on page 3 of the directory. Reminder that SW means "state dues deduct": \$2.50 is withheld each month from your TRS pension amount for an annual cost of \$30. If you pay once a year as a state annual member, the cost is \$40. <u>SW yields a savings of \$10</u>.

Local Blackhawk dues are \$15.00 and must be paid by December 31, 2019 for members to be included in the 2020 directory. Dues may be brought to the September, October, November or December monthly meetings. If you prefer, you may mail dues to:

Checks are to be made payable to <u>Blackhawk Unit – IRTA.</u> Please include changes in name, address, phone number and email address with check.

If you will be 90 or older in 2020, notify Nancy McManus at 794-0490 of your name and birthdate. At age 90, both local and state memberships will be credited as LIFE, with no further dues collected, **BUT** a birthdate must be sent to the state IRTA office.

#### DIRECTORY COMMITTEE

One of the Blackhawk Unit's biggest expenses is the printing and mailing of directories. This becomes even more expensive if the post office cannot deliver your 2020 directory in January because you are spending the winter away from the Quad-Cities. The post office will throw away directories that are undeliverable – so in order for you to receive a directory, we need to pay a postage notice and have another directory printed for you. Each year we have been doing better, but we need your help to improve the situation.

There are three easy options to avoid this:

- If you would like to have the directory mailed to your winter address, please notify us of that address.

- If you would like to have it held until you return and you will pick it up at a monthly meeting, please let us know that and we will bring your directory to that meeting.

At this time, I have not received the TBK Bank July Balance Sheet Report. This may be due to the fact I have moved & my mail is being forwarded. The ending June balance was \$2,653.64 & unless College for Kids cashed their award check there was no activity. 2019 Bridie for Charity pledges were \$2,193.83 exceeding 2018 pledges of \$2,145.88. Thirty-nine pledges were made representing 43 members (4 husband/wife). This represents 6.3% of the membership. As of 7/19/19 \$872.00 of the amount pledged has been paid. There were 30 contest entries & the unlikely winner was Steve Haines guess of 2049. There were 2091 birdies made. I have decided to donate the winnings back to the foundation. Thank you to all who pledged.

#### LEGISLATIVE UPDATE - JOHN FLAHERTY & ART YOUNG

Things are pretty quiet in Springfield now. The Governor is busy signing bills and legislators are back home trying to get to as many local events as possible.

No one is mentioning that Illinois cannot have a balanced budget or talking about just how big a deficit we will "discover" next summer.

Illinois legalized cannabis and recreational sales will begin in January. More casinos were added and more slot machines in every gaming facility. That money will start coming in shortly. Gasoline taxes went up 19 cents a gallon July 1st and that revenue will be used for projects on roads and bridges.

There is no talk of legislation affecting our pensions or benefits at this time. Our IRTA Legislative Team is working at meeting new legislators and educating them on our pensions. Your help is appreciated anytime that you see any of our local legislators. All of our local people have supported us and be sure to thank them for their support and let them know that you appreciate what they do for their constituents.
