LEGISLATIVE UPDATE - JOHN FLAHERTY & ART YOUNG

The Illinois legislators are not meeting now. Some committees have met by Zoom but nothing will happen in the near future.

The main item for discussion seems to be the Progressive Tax that will be on the November ballot. There are many pros and cons to this and the IRTA has not taken a position on this since we do not pay state taxes on our pensions or retirement investments. If this does pass, it will not affect taxing retirement income. The legislature can decide to try to tax retirement whether it passes or fails, but we do not believe that they will try this unless something drastic happens to change their minds.

Speaker of the Illinois House, Mike Madigan, has been under fire and it is rumored that the Fed's are looking into his activities. Mr. Madigan does not use email or own a cell phone and unless some people are willing to testify to any illegal activities there does not seem to be any evidence to indict him.

Many of you will choose to vote by mail in the November election. Make sure that you return the form to the county clerk to request a ballot. We do not know what the Coronavirus situation will be in November, so play it safe. If you are at all concerned about your health, then request a mail-in ballot.

DO YOU HAVE A NON-CERTIFIED SPOUSE? I DO, AND THIS IS WHAT WE DID ABOUT IT!

I have been an IRTA and Blackhawk unit member for over a decade. By being a member, I know that I am supporting the one organization whose sole goal is to protect the interests of retired Illinois public school educators. My wife, Ann, also benefits from my membership in IRTA, because they are essentially looking out for her benefits, too. If she outlives me, she will still have a TRS pension benefit. In order for her and others to continue with IRTA, an Associate Membership is available for those who are not eligible for a TRS pension on their own.

Associate IRTA Annual Membership is \$25/year and an Associate IRTA Life Membership is available for a \$125 one-time payment. We went the life route. If she outlives me, she will continue to benefit from legislative representation and advocacy for improved benefits, legislative updates, the quarterly IRTA Action news bulletin, and very importantly, uninterrupted access to member benefits. Our Blackhawk Unit has seen a number of members make this same choice.

If you are one of that large group of IRTA members whose husband or wife was not a teacher eligible for a TRS pension, I encourage you to do the same thing that we did and have your spouse also join IRTA as an Associate Member.
