2019 BLACKHAWK UNIT PLEDGES SURPASS LAST YEAR

Thirty-eight Blackhawk Unit members made pledges to John Deere Classic Birdies for Charity for a total of \$2,264.68 surpassing the 2018 total of 36 pledges for \$2,145.88. John Deere paid 7.25% of each of the 542 charities individual totals. Blackhawk Unit received \$164.16 to make the final 2019 Birdie total of \$2,357.99 The J.D.C. received 19,978 individual donations totaling \$13.82 million raised.

There were 2,091 birdies made and the unlikely winner was Steve Haines, Foundation Executive Director, with a guess of 2,049. Steve donated his winnings back to the Blackhawk Unit Foundation. Thank you to all who pledged.

A \$50 memorial for Blackhawk Foundation Founder, John Henriksen, was received. The checkbook balance as of 10/31/19 was \$4,942. If you have an organization that you wish to be considered for a 2020 grant award please submit it to Steve Haines prior to the new year.

Dear Retired Educators and Administrators,

I hope the upcoming holiday season finds you and your family in good health.

As many are aware, there is a substitute teacher shortage throughout not only Rock Island County, but throughout the state of Illinois. If you are interested in serving as a substitute, you may do so for 120 days or not more than 600 hours in a school year until June 30, 2020 with the passage of (40 ILCS 5/16-118). If you are interested in becoming a substitute teacher after retirement, please contact the Rock Island County Regional Office of Education to learn more.

LEGISLATIVE UPDATE - JOHN FLAHERTY & ART YOUNG

The 2019 Veto session is over and our legislators are done for this year. Several legislators (Tom Cullerton, Martin Sandoval and Luis Arroyo) are under investigation by federal agencies and some have been indicted. The rumors are that the Feds are looking for a bigger fish and trying to find someone to testify against them.

The bill to consolidate the downstate police and fire pensions was passed. There are currently more than 640 of them. The interesting thing is that SB1300 included a fix for the Tier II pension for Police and Fire. They will get the full cost of living instead of only one-half. This shows that the state realizes that they will also need to fix Tier II for the five state retirement systems.

Our legislators will be back in session on January 22, 2020. Recreational cannabis sales and new gaming regulations take effect on January 1st. There will probably be bills introduced to correct problems with these issues as they arrive.

Expect to hear talk of how everyone needs to vote for the new "Fair Tax". We will vote on this next year. It will be interesting since it requires a change to our state Constitution. The IRTA Legislative Committee will be discussing whether we should take a stand on this issue.

As always, our IRTA lobbyists will keep us informed on and new bills that are filed.
