DALY TO HEAD BLACKHAWK UNIT FOUNDATION

Mike Daly will succeed Steve Haines as Executive Director of the Rock Island County Retired Teachers Foundation. Haines has led the charitable arm of the Blackhawk Unit for the last three years and submitted his resignation at the January 2020 Annual Meeting.

Eighteen 2020 Grant Awards totaling \$3,050 were approved by the foundation's board of directors including giving \$200 to every public high school and Alleman for their academic awards program. Dear Retired Educators and Administrators,

Spring is nearly here! That means, it is almost time to renew your Professional Educator License (PEL). Beginning April 1, 2020, you will be able to renew your

PEL if your current license expires as of June 30, 2020. As a reminder, if you have served as an educator or during your five-year licensure cycle, then you will be required to submit professional development hours in your Educator Licensure Information System (ELIS) account prior to renewal. ELIS will prorate the number of professional development hours that are required during your licensure cycle.

Indicate in your ELIS account the number of semesters that you have been retired by logging into your ELIS account, and selecting the yellow Profile box at the top right side of the page on, Click Here to Update Your PD/Employment Status. This will allow you to select each semester in which you have been retired and not under contract utilizing your license. Click finish at the bottom of the page and the changes will become effective for your account.

LEGISLATIVE UPDATE - JOHN FLAHERTY

I am writing this before the Governor gives his budget address on February 19th. That is where he will tell us if there are plans to fully fund pensions for next year. Last year he stated that he would underfund them by about \$900,000,000, but magically found the money less than a week later.

Governor Pritzker has already given his State-of-the-State address and the underfunding of public pensions was not addressed. A few weeks ago it was announced that pension liability has grown to over 137 billion dollars. This year pension funding accounted for 22% of the budget.

Springfield has a lot of problems this year. There are legislators under indictment, legislators resigning, legislators moving from the House to the Senate to replace those who have left office and a new Senate President. There have been loads of changes and there are rumors that the federal investigators are not done yet.

Cannabis sales seem to be going well, but I have not heard how much revenue is actually being generated. Slot machines were increased in bars, restaurants and the many places that have opened almost on every corner. Those machines can now wager twice as much as before and payout double what was previously allowed. There is still no plan for the new mega-casino that Chicago is allowed to have.

One interesting development, when the consolidation of the down-state police and fire pensions was passed, is that the bill also corrected the Tier II police and firemen to increase their pension annual cost of living to be the same as Social Security. This shows that our legislators realize that they must provide a fix if they want to continue to avoid paying Social Security for that group. All the other state pension systems still have the Tier II pensioners staying with the one-half of what the federal government calculates for their cost-of-living index.
