#### SCHOOL-BASED HEALTH SERVICES EXPANSION

The Biden administration has approved a Pritzker administration proposal to expand the Illinois School-Based Health Services program which will bring in additional federal matching funds to provide covered services for Medicaid-enrolled students across the state, including critical youth mental health services. The approval means that the state will receive federal dollars for students who receive things like behavioral health services, preventive care, physical and occupational therapy, and other services covered by Medicaid. Previously, this reimbursement was limited to students who had an Individualized Education Program (IEP). The expansion is expected to bring tens of millions of additional federal Medicaid dollars to schools.

**RELATED:** Moline High School brings Health Clinic inside its walls. In total, the clinic can provide these services:

Well Child visits Behavioral health Nutrition health education STD testing

- School physicals Mental health Immunizations Pregnancy testing
- Sports physicals Counseling referrals Lead screenings

The clinic is open to all Rock Island County youth and aims specifically to serve those whose health care needs might not be met. "Our goal is to provide a medical home for children in need," School Health Link Board Chairperson, Scot Meskimen said. "We primarily serve patients who are uninsured, underinsured or on Medicaid, but we also take most insurances and will not deny care for services based on a family's ability to pay. ... By entering the school, we increase the accessibility to care for hundreds of kids. Additionally, by increasing our presence in the schools, we will have the ability to be more proactive with our care," Meskimen said.

"It just makes it far more accessible for the family," Moline Superintendent Rachel Savage said. "Sometimes, it's very hard to get an appointment with private medical providers, especially this time of year. So having an additional provider in the community helps those families get those appointments."

School Health Link is open from 8 a.m. to 4:30 PM Monday-Friday, with 24-hour emergency care available through Trinity Emergency Rooms. Transportation to the clinic is available to all students through MetroLink buses, which are available for free to all students with a school ID.

IRDIES FOR CHARITY

#### LEGISLATIVE UPDATE – JOHN FLAHERTY

There have been 2,581 Senate bills filed and 4,089 House bills filed. The IRTA staff is closely watching any bills that could affect our pensions or benefits. Our Executive Director, lobbyist and contract lobbyist are spending time with legislators to keep reminding them that retirees vote and are concerned that the state fund us as they are constitutionally required to do. The legislature is scheduled to finish on May 19<sup>th</sup>, but seldom meets the posted deadline. As soon as the budget bill is posted, our staff will check the numbers for funding this year's pension and insurance payments. Budget bills can run 1,500 pages and every funding line needs to be scrutinized.

Keep an eye out for any emails that will alert you if a bill surfaces that could impact us. IRTA will send out a "Voter Voice" alert to every member that has an email address on file with them. You must open it, add any comments that you wish, and send it. It will automatically go to your state representative and senator. If you talk with any retired educators who are not IRTA members, point out that for \$2.50 a month they can help keep their pensions and insurance benefits funded.

Don't forget our legislators did manage to squeeze in a bill to give themselves a 6.9% raise at the end of the last session. This makes their base salary about \$80,000. They met for 45 session days last year so that works out to \$1,778 dollars a day, not counting the per diem they received for 40 of those days.
